Digital Image Specs

All painting images for the Juried Show are to be entered ONLINE at www.onlinejuriedshows.com between April 20 thru April 30. Just click on “Laguna Plein Air Painters Association Less is More” and follow the instructions. You may enter up to 5 images. Image entry questions should be sent to info@enfaonline.net

All images need to be sized to 1920pixels x 1920pixels @72dpi. See the ‘How To:’ on www.onlinejuriedshows.com for more information on digitally preparing your images.

Images entered WITHOUT a received mailed Entry Receipt Form (available after you enter your images) with fees by the POSTMARK DEADLINE of April 30 will NOT be juried.

All Juried RESULTS will be emailed to artists by May5th. You will receive an email for each image entered. Delivery Instructions of JURIED IN paintings will be attached to that RESULT e-mail.

Participation Rules

1. Original Plein Air paintings. Open to all subject matters and mediums
2. Size Limitations: 20 United Inches unframed 36 United Inches framed
3. Entries must not violate copyright laws

Sales

Randy Higbee Gallery will handle all sales and collect all sales tax. Artist's 50% of sales price will be issued by LPAPA 15 working days after the closing of the show.
