# RULES OF ENTRY REQUIREMENTS - - - PLEASE READ COMPLETELY

## EXHIBIT THEME

The theme of this show is "The Art of the Square". Artists may interpret this theme as they so choose, but **all artwork must be in a square format.**

## ELIGIBILITY

- Work must be your original artwork, not done under an instructor's supervision, and not exhibited in any previous WPW show. Work completed in last three years only.
- Once artwork is submitted the artist may not withdraw it. No substitutions of accepted works will be allowed. No artwork may be removed from the gallery prior to closing of exhibit, including sold artwork.
- **Artists whose work is accepted are requested to assist with the exhibit** (*take-in, take-down, or reception*).
- You may submit NFS (not for sale) artwork.

## SPECIFICATIONS

- Metal or neutral wood frames only. Neutral colored mats only, of professional quality and in good condition. Colored liners are acceptable.
- Wiring must be in good condition and substantial enough for the weight of the artwork. Wiring must be wrapped with tape at ends. **NO SAWTOOTH HANGERS** accepted. All artwork should be ready to hang on the wall for the exhibition.
- All drawings, watercolors, pastels, etc. must be covered with plexiglass. No glass accepted.
- Works on paper and fragile artwork must be mounted on a sturdy support.
- Canvas edges should be painted if no frame.
- Delivered work must match the image juried. No substitutions of accepted works will be allowed.
- Prices quoted on the entry form may not be changed after acceptance.
- Attach a label to the back upper right corner of each piece and have a signed release form to give to the volunteer at take in. See page 4 of this Prospectus for labels. One label is required for each painting accepted.
- **ALL WORK MUST BE IN A SQUARE FORMAT maximum size including frame is 24"x24."**

## ENTRY PROCEDURE

Artwork for consideration by juror must be entered in the **OnlineJuriedShows.com** website by **5pm Sunday, December 29, 2019.**

## FEES

**\$45 for two** entries and each **additional entry \$5** up to 6 total. All fees must be paid by the entry deadline and are non-refundable and payable through the <http://www.onlinejuriedshows.com> website. Credit Card or PayPal are accepted.

## DISCLAIMER

Entries not meeting the criteria listed above will be disqualified and the entry fee will not be refunded.

## DIGITAL IMAGES OF EACH PIECE

- Digital format: JPEG
- Entry form must be filled out in its entirety. List sizes up to the nearest inch. Submitted images must not include matting or frame. Crop the photos to include only the artwork. Be sure your images are right side up.
- Before uploading your images, make sure they are smaller than 4MB, but at least 1920 pixels on the longest side at 72 dpi. Images should be in JPEG format, sRGB color space. ## GALLERY SALES

- All sales are final.
- Gallery will receive 25% commission on any and all sales during and as a result of this exhibit.
- Artist will receive 75% of sales price.
- Sales tax is added by the Gallery.
- Any artwork without a sale price on the entry form will be considered NFS ("not for sale")
- Prices cannot be changed from those stated on the submission.
- Artist should expect payment within 30 days after the close of the exhibition.
