## ABOUT THE EVENT

The Queen City Plein Air Festival is a biennial Plein Air event hosted in the heart of the beautiful Sheanadoah Valley. The 3<sup>rd</sup> Biennial Festival is hosted by the Beverley Street Studio School, a non-profit art education facility in Historic Staunton, VA. For the first time, the QCPAF will be a juried event as it continues to grow in size and popularity. Juried artists will compete for over \$3,500 in cash, and several gifts and prizes. Artists will paint for three and one half days at exclusive locations around Augusta County, have multiple opportunities to show and sell their work, as well as have the option of participating in several events designed to promote the participating artists to the local community and collectors.

# ELIGIBILITY REQUIREMENTS

- Entrant must be at least 18 years of age
- <u>There will be no refund of jury fee if disqualified for non-payment of dues by</u> <u>deadline</u>. <u>NO EXCEPTIONS</u>.

### JURY FEE:

To be considered for participation in this 5-day event, artists may submit 3 images representative of their best plein air work and pay a non-refundable \$25 jury fee. Applications are processed through <a href="http://www.onlinejuriedshows.com">www.onlinejuriedshows.com</a>

### THE JURY PANEL

A panel of three (3) will blind jury the applications. Acceptance to QCPAF is based on the <u>overall quality of work submitted</u>. Event participation will not exceed 27 with a "stand-by" list of 5 in the event of artist cancellations. The decision of jurors is both nonnegotiable and final.

### **NOTIFICATION OF ACCEPTANCE:**

Artist will receive notification of determination by email. Accepted entrants will receive an additional mailed letter with registration instructions, lodging request, and

other pertinent information. Submission of application and, later, entry fee constitute agreement with all conditions set forth in this prospectus.

## ABOUT BSSS AND THE EVENT

Located in the historic district of downtown <u>Staunton, Virginia</u>, Beverley Street Studio School (BSSS) has adopted as its mission "providing the community and region with a variety of opportunities to explore the world of the visual arts through practice, professional instruction, and contact with practicing artists".

Founded in 1992, Beverley Street Studio School (BSSS) began with a group of five professional artists who sought to establish a studio art school that would provide an opportunity for those in the region to engage in art training in a collaborative and nurturing fashion. The emphasis in instruction is working from direct observation, whether in a plein air setting or within the studio classrooms. It is now an established organization and integral part of the local and regional cultural community. The School distinguishes itself from other art organizations in the region by offering year round non-degree college-level art classes to the serious art student. In addition to the core curriculum and as part of the School's mission to make art accessible to everyone in the community, BSSS offers: an art gallery with rotating exhibits by guest artists, instructors and students; several offsite exhibit opportunities; a high quality Travel Study program; Open Session figure drawing; and numerous free community programs including monitored art discussions, lectures, and peer critiques.

BSSS is a non-profit organization led by a Board of Directors, Executive Director, and Administrative Assistant with assistance from many volunteers. It is supported in part by the Virginia Commission of the Arts and the National Endowment for The Arts. There are over 250 members, 50 volunteers, and approximately 120 active students.

# **QCPA 2020 PARTICIPATION RULES:**

- 1. There will be no exceptions to deadlines, specifications or rules.
- 2. Participants must abide by rules of the event as outlined in prospectus
- 3. Participants must participate in event activities as listed in event itinerary (distributed at orientation)
- 4. Participants must attend welcome reception and fresh paint sale.
- 5. Participants must bring a previously completed plein air work to display with their bio for the opening reception on April 14<sup>th</sup> (may be a for sale or NFS work)

- 6. Paintings must have event stamp and be created during the official painting period of April 15-18, 2020 to be eligible for awards.
- 7. Paintings must be for sale with a \$500 minimum price. No exceptions..
- 8. Sales split: 40% to BSSS and 60% to the artist.
- 9. Minimum size: No Side smaller than 9" excluding frame. No Exceptions
- 10. <u>Maximum size:</u> <u>No side may exceed 36 inches</u>, including frame. No exceptions.
- 11. All work must be in gallery quality frames "wired" (no saw-tooth hangers) and ready for hanging. No exceptions.
- 12. Pick up of unsold work by the artist or artist's agent April 19, 2020
