Crop the photos to include only the artwork.  
Be sure your images are right-side-up.  
Before uploading images, make sure they are smaller than 4MB, but at least 1920 pixels on the longest side at 72 dpi.  
Images should be in JPG format, RGB color space.

All 2D and 3D media considered. Artwork must have been created within past 3 years.  
Artwork must be original and not previously exhibited at Front Porch Gallery. Artwork must be ready to hang with proper hanging device. No saw tooth hangers.  
Artwork must be for sale. Gallery retains 40% commission on sales.  
Size of work limited to 70" on length side, 72" on height side -including frame.  
For this exhibition we are looking for artwork that includes all themes of expression, suitable for general public.  
Artwork must be labeled on the back with artist's name, title, medium, size and price.  
Artwork must remain in the gallery for the entire exhibition, unless sold.  
Accepted Artists must complete the Consignment Agreement. Commissions are paid within 30 days of sale.  
A W-9 is required for payment.
